Papers are to be submitted as a single PDF file- with title, authors' names and affiliations, an abstract of maximum 200 words, a maximum of 3 JEL codes, and a maximum of 5 keywords- attached to an email sent to ermas2016@gmail.com. The call for papers is open since February 1st, 2016. **The deadline for paper submission is March 31, 2016, 23.59 hour (GMT+2=Romania time)**. If you do not receive a confirmation of your submission in two-three days, please re-contact us. Anybody can **submit a single paper**, although s/he can be author of other papers submitted (by co-authors). Please mention in your submission email who is the proposed presenter, in case of multiple authors. **The papers and presentations will be in English**, but the selected presenters must be prepared to possibly interact with the audience also in Romanian.
